Vetting: By Committee

Vetting times: Trials: 8:45am – 9:15am. Tests: 12:15pm – 12:45pm.

Bitches without proof of desexing only; bitches in season will run at the end of the day. All exhibitors to pass through the checkpoint by close – handlers that are not at check-in will be marked absent.

Safety: All exhibitors shall abide by the ANKC Herding Rules (2023).

Certificates & Sashes: All Qualifiers

Awards: First place rosette to A Course class winners. Rosette & Prize to High in Trial and rosette to Reserve High in Trial – combined score over both trials.

Note: Competitors wishing to use a stock stick must provide their own. As of 1/1/2023 the Instinct Test (certificate) and Herding Test (title) are optional classes. Handlers participating in Instinct Tests are strongly encouraged to provide their own long line (2-5m). Where injury to stock is caused by the dog, the Club reserves the right to seek replacement cost from the owner/handler.

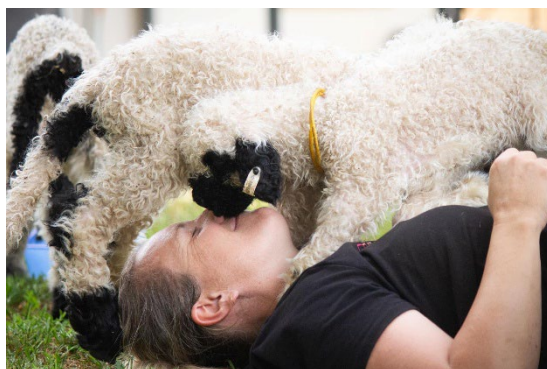
