Vetting: vetting to be conducted by owner (wiping vulva to check for oestrus) and shown to the vetting officer for clearance.

Vetting and check in time: 8:00 am to 8:30am. Bitches only without proof of desexing.

Dog measuring: 8:00am to 8:30am for dogs without a height card

Dog heights - Under 30cm, 30 – under 45cm, 45cm & Over – Dogs must be measured prior to competing.

All dogs to pass checkpoint by close. Set up to commence at the completion of Check-in.

Briefings: Will be started once setup is complete

Judging commences: Not before 9:30am

Entry fees: NCODC Members \$20 per entry Non-NCODC Members \$25 per entry

Running order: to be confirmed on the day – Run sheet will be made available.

Catalogues: Link will be sent via email to exhibitors at least 24 hours before the start time.

Sashes: At completion of pack down – Certificate & sashes to all qualifiers.

Catering: By NCODC committee.

Important SprintDog™ Trial details

- This trial will be using a continuous loop lure and have an enclosed catching pen.
- People entering the event must organise their own handlers – All handlers must be financial members of an ANKC State body.
- All Handlers must be at minimum 16 years old
- One Handler releases the dog, another handler catches the dog at the end of the track
- The catcher can call the dog prior, and whilst the dog is running for encouragement but must be mindful

of the body language displayed by the dog, as to not distract from chasing the lure.

- Dogs run individually after a lure down a straight course and are timed
- Maximum 3 dogs per entrant
- Dogs recommended to run naked (i.e. without any collar), but if a collar is worn, must align with rules

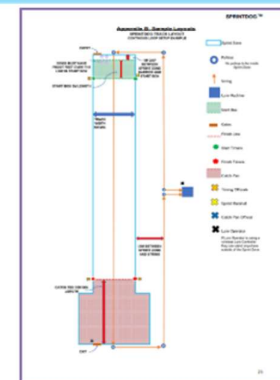

Thank you for taking the time to enter our SprintDog™ event.

Please be aware of the following:

- There will only be 'fun runs' at this trial if weather permits.
- There will be catering and hot and cold drinks in the canteen. See menu below.
- Both cash and EFTPOS available (*with a minimum \$5 spend for EFTPOS*).

We encourage you to read through the SprintDog™ rules thoroughly and the Dogs SA code of conduct before the event.

This trial will also be run in conjunction with the 'Battle of the States ~ Australian 100m Sprint Competition'. Results from this trial will be collated with all other South Australian results. Each dog's call name, dog's registered name, dog's registration number, owner name/s and dog's height will be shared on the BOTS Facebook page. We will also share your dog's height and date of birth with the coordinator to ensure dogs are recorded in the right category. We will share the dog's actual times from this event for collation with all results for South Australia.

This is a formal trial and as such we will be adhering to the rules. It is expected that every entrant is familiar with the rules and obligations. Please follow the instructions of our volunteer officials.

How will the day run?

Before you arrive:

Please print or hand write your dog's number/s (one each the catcher & releaser).

8:00am to 8:30am Height measuring:

Please check in at the check in / registration desk first.

If your dog does not already have an official height card a Dogs Australia Judge and/or NCODC official will be on hand to measure your dog and place them in one of the 3 height categories. These height cards issued are only for use at SprintDog™ events and are not transferable to other sports.

8:00am to 8:30am Check in and vetting:

All Handlers must pass through check point by close of vetting. Bitches without proof of desexing to be vetted.

You must check in your dog yourself, no one else can check you in!

Please have your current Dogs SA (or state affiliate) membership card for both Handler and Catcher ready to show at check in.

If you have an official SprintDog™ Height Card or an official height card from another Dogs Australia sport please present it upon check in.

If you plan on using a muzzle on your dog please present your dog and muzzle at check in for a fit inspection.

Setup

Once your dog is measured (if required) AND you are checked in – please support the event to start on time by helping to setup the sprint zone.

9:20am Briefing:

ALL Releasers and Catchers must attend the pre-event briefing near the clubrooms. This will cover important safety information as well as how the day will run. In line with Rules and Regulations of the SA Canine Association Inc trading as Dogs SA, **dogs are not permitted to attend the briefing.**

9:30am Dogs due to commence their runs.

Dogs run order

Dogs will run through from number 1 to 50 (group 1) and then we will break for stewards to swap roles. We will take a break for up to 30 minutes once all dogs (both group 1 and group 2) have completed the first run. Once we have completed the break we commence running through the numbers from start to finish again (excluding those dogs that were excused in their first run).

Please make sure your dogs are warmed up and cooled down to prevent injuries.

- Please make sure your releaser and catcher are ready and waiting at the designated spots. If you fail to pass through the Gate Steward at the time of your number being called you will be moved to the end of the running order.
- The person releasing the dog is to wait in the waiting area. The person to catch the dog is to wait in the marshalling area near the catching pen **(not behind the catching pen as this may distract some dogs)**. Once your dog has run you can then leave the area.
- The Trial Manager/Secretary will need some time to prepare Qualification Certificates at the end of trial. Please be patient.
- The committee will need help after the Trial to pack up the venue. We kindly ask that you volunteer time at the end of the trial to assist with taking down onion mesh etc.
- SprintDog™ is a very volunteer heavy sport and your offer of assistance or willingness to watch and shadow a role would be very welcome.

Presentations and pickup

- We will present qualification ribbons at the end of the day near the clubrooms. In line with Rules and Regulations of the SA Canine Association Inc trading as Dogs SA, **dogs are not permitted to attend presentations.**
