Check-in and Vetting: As specified above. Bitches only without proof of desexing to be in vetting area. All dogs must pass through check point by close of vetting. All elements listed are one single trial and therefore Rule 8.1.3 applies.

Judges Briefing: As specified above.

Entry fees: \$17.50 per element

Catalogue: Available from Top Dog events or PDODC Facebook page 2 days prior to trial

Entry Limits: Entry limits as specified above. Should balloting be required, this will occur via Zoom on Thursday April 17th at 6pm.

Entry amendments: Competitors should only enter those elements that they are eligible to enter. After close of entries no further amendments to the catalogue will be made except for balloted entrants entered back into the trial. Refunds after close of entries will only be available for balloted entries that do not receive a place back into the trial and will be processed after the trial date.

Judging Order: As specified in the catalogue. Judging may commence with judges and stewards' dogs followed by the remaining competitors.

Sashes and Prizes: Ribbons to all qualifiers and BOW WOW prize for 1st, 2nd and 3rd place. Kong prizes as outlined in the catalogue.

Notes: It is not appropriate to train scent work at the trial location prior to trial date. For this trial a period of 30 days applies except where the training is an approved PDODC scent work training session/workshop. As per ANKC Scent Work Rule 11.1.1, where suitable, a dedicated spectator viewing area may be established for Advanced and Excellent level elements on Sunday April 27th. No spectator gallery will be available for Novice elements on Saturday April 26th. Competitors should be aware that Jenkins Reserve is a public reserve with an off-lead dog park. Members of the public and their dogs may be present at the trial venue, particularly within the competitor parking area during the trial.

Paper entries must be submitted on the official scent work entry form. Please contact trial secretary for direct deposit details if intending to submit paper entries. Email entries not accepted due to online entries being available.

Catering: No catering will be available at either venue. The venue is located near takeaway food outlets.

Hot Weather Rules: If required the Dogs SA hot weather rules for Scent Work will be applied. If cancelled due to the Hot Weather Rules, Extenuating Circumstances or the Extreme Weather and Safety Rules, no entry fees will be refunded.

Competitor check in, vetting and briefing

Competitor check in, vetting and briefing will occur in the competitor parking area on both days as below unless communicated otherwise. Please ensure you take note of arrival times and parking information to ensure you do not interfere with other competitors who may be in sessions before you. All dogs are required to check in within the check in time specified. *Only dogs that require to be vetted should be within the vetting area during the check in time. No dogs should be present at the competitor briefing.*

Search areas and trial precinct

All competitors should ensure that they are familiar with the areas indicated on the following pages that can be accessed on the day of the trial and those area that should not be accessed unless under direction of a trial official. Please remember that Jenkins Reserve is a public space and that not all individuals present within the trial precinct will be a trial competitor. If you are concerned that a competitor is accessing an area that they should not be in please raise this with one of the trial officials as soon as possible.

Please following any signage and direction of officials carefully.

Running of searches

Competitors will be called according to the catalogue order as listed. *Trial officials may complete their searches first before remaining competitors begin to be called. If this is to occur it will be communicated at the trial briefing.*

All competitors should ensure that they are nearby 2 - 3 competitors before they expect to be called to ensure that you are ready when call. If you anticipate a clash please identify this with the carpark marshals as early as practical. They will place someone in ahead of you however you should then report to them once you have completed the clashing search for immediate marshalling to your next search.

Any competitor absent after 3 calls will be marked absent and not be allowed to participate in the search

Ribbons will be available to all qualifiers. ***There is to be no dogs present at presentations.*** Where possible those competitors who gain a placing or award are asked to get their dog following presentations for photos. A prize for 1st, 2nd and 3rd place has been generously donated by Bow Wow.



Special Prizes and Awards

KONG Encouragement Award

The Novice element judges will each award one Encouragement Award to a non-qualifying team who attempted their search.

PDODC Members Only KONG Team Prize

The PDODC Members Only KONG Team Prize celebrates the strong and supportive club culture that exists at PDODC training and trials in the discipline of scent work. PDODC members can nominate a team of four members for the PDODC Members Only KONG Team Award. A prize is available for an Advanced Team and an Excellent Team. The following criteria applies:

- 1. All team members must have participated in PDODC affiliate members scent work training in 2025.***
- 2. A team must consist of 4 different handlers all competing in the same class (ie all Advanced or all Excellent).***
- 3. Each dog can only be entered in one team but handlers may be part of more than one team.***

Points will be awarded as follows:

- Qualification and 1st Place – 8 points
- Qualification and 2nd Place – 7 points
- Qualification and 3rd Place – 6 points
- Qualification (no placing) – 5 points
- Non-qualifier – 4 points
- Disqualification (providing not report is made) – 2 points



Where a draw occurs the winner will be the team with the fastest overall team time.

Completed Nomination Forms must be provided to check-in stewards **before** the judges briefing for the applicable class.

For this trial no scent work training may be conducted at grounds for a period of 30 days prior except where the training is PDODC affiliate club training.

Any competitor arriving at the grounds with target odours other than a person engaged in the administration of the trial SHOULD NOT arrive before the start of the specified vetting time and should immediately contact the trial manager for storage of any odour for the duration of the trial.

C. CODE OF CONDUCT FOR EXHIBITORS

Dogs SA Exhibitors Code of Conduct

1 – 3 While competitors should always read the rules, they are strongly encouraged to refresh themselves on the following rules:

Spectator Gallery

A spectator area may be available for this trial for the Sunday elements only at the judges discretion. Section 11 of the rules relates to spectators.

All competitors and potential spectators and competitors should ensure they are aware of the rules in relation to spectator areas and abide by these at all times.

Anyone suspecting that there has been communication between a spectator and competitor should raise their concerns immediately with the SACA rep or any other trial official.

Trial Logistics

On the day of the trial all dogs should remain in the carpark unless specifically being directed to a search area by an official. The entire area of Jenkins Reserve including the area towards, and the area of, the dog park, is considered to be part of the trial location. Dogs can be toileted in the area behind the designated competitor parking area as indicated. Competitors can also toilet their dogs up the hill back along Saints Road but **MUST** keep the footpath on their right going up the hill and on their left coming down the hill. Competitors **MUST NOT** walk up to Saints Road along the roadway or footpath. Competitors are asked to drive at walking pace only in the carpark. Please also be mindful that the reserve and the surrounding area is a public space and that there may be members of the public in the carpark. ***If a competitor has a concern about a member of the public then please speak with a trial official for them to approach the person rather than you approach them directly.***



Access to toilets

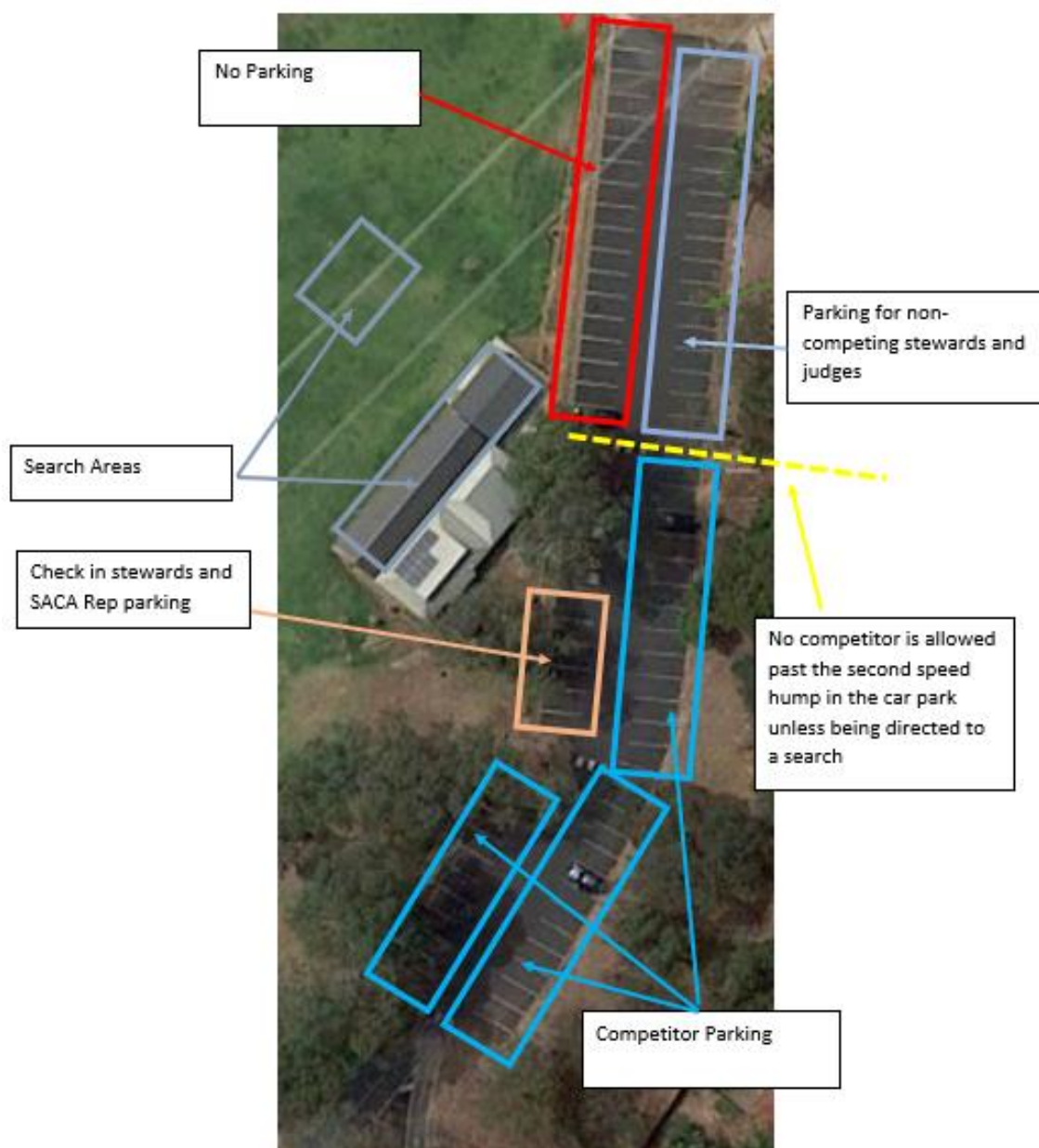
No dogs should be in the area of the toilets unless they are an Assistance Dog. Competitors should access the toilets via the path heading from the carpark near the disabled parking spaces and stay on the path between the disabled toilet and the main building. All competitors should then return the same way. The female toilet will be out of bounds to competitors and all competitors will need to use either the male (exactly the same as the female) or disabled toilet. As the area around the toilets will be used for marshalling of competitors and is near the search areas competitors should not linger in this area. Please also be mindful that cars in this area may have dogs in them so please consider this when moving around in the area.



Parking and Search Areas

Please park in the areas indicated below ensuring that you park in the area relevant for you. There will be frequent foot traffic of people and dogs up and down the carpark so consider this when parking your car. If you have a dog that can be reactive please consider bringing sheets or towels to block their view and consider what direction you will park your car.

The search areas for the trial are indicated below but this may be subject to change based on weather conditions. Competitors should not leave the carpark and move towards a search area unless instructed by a trial official. As much as possible when you are not toileting your dog, moving to the staging area, or returning from your search, it is asked that dogs are in crates or cars. This will reduce significantly the number of dogs in the carpark and create a much calmer and quieter trial for everyone but in particular those that may have anxious, nervous or reactive dogs.
