Welcome

The Organising Committee would like to thank all of the entrants in the club's 2025 Rally and Tricks Trial for their entries and hope you have an enjoyable and successful trial. They would also like to thank all of the Judges and Stewards for their time and also those helping in the office, and canteen and all others who have offered help.

Vetting

Dogs entered in both Rally and Trick are only required to present for vetting for the Rally trial. Those entered in the Tricks trial only should present to the office during the allocated vetting time to register.

Only dogs that require to be examined during vetting are to be present in the vetting area. If your dog doesn't need to be vetted please do not bring them with you to vetting. No other dogs are to be under the verandah at any time during the trial unless with prior permission of the Trial Manager.

Exhibitor Numbers and Running Order

It is asked that all entrants ensure that they report promptly to the ring when called. For those entered in multiple tricks classes, it is asked that you communicate to the ring stewards sooner rather than later if it looks as though you will have a clash on the day. Entrants not reporting to the ring in a prompt manner when called may be scratched. It is your responsibility to communicate with ring stewards not that of other competitors. It is asked that people consider other entrants when walking past and between the rings to avoid distraction for the dog in the ring.

Catering

The Affiliate will provide a standard bar jump for competitors performing Starters Trick S.10

General Procedures

Individual Score Sheets

Once a competitor has left the ring they are asked to ensure that they move away from the ring exit area to wait for their individual score sheets. Once a competitors result has been recorded the scribe will get the attention of the competitor who can approach to collect their score sheet. Competitors please do not to approach the scribe to request their score sheets at any time as they may be busy doing their job.

Any individual score sheets not collected by the conclusion of judging of that class will be shredded.

(f) suffering from an infectious or contagious disease or had been exposed to the risk of such disease during the period dating from five weeks prior to the Exhibition. This also includes a dog brought onto the grounds at an Exhibition and is not exhibited;
