

^^The Novice Interior Search will include an extended briefing to guide competitors through what they can expect at a trial and some of the more important rules. An extended debrief will also be provided after all competitors have searched. All competitors should however still ensure that they have read the ANKC Rules for the Conduct of Scent Work Trials (<u>https://dogsaustralia.org.au/members/rule-regulations/rules/</u>)

**Observer only positions are available for both elements. Usually Novice elements do not allow spectators but since this is a mock trial a small number of places are available for those not comfortable to enter. It is expected that observers will still attend for check-in, competitor briefings and debriefings.

Target Odours: Novice - Anise; Excellent - Anise, Clove, Birch

Check-in, Vetting and Judges Briefing: As specified above. No dogs to be in the check-in area. Competitors with entire bitches are responsible for ensuring their dog is not in season prior to attending.

Entry fees: Novice Interior and Excellent Containers: \$10.00; Observers only: \$5

Catalogue: Available from Top Dog events or Scent Work SA Facebook page on Friday February 28th

Entry Limits: Entry limits as specified above. Once limits are reached no further entries will be received. Only one entry per class per handler.

Entries: Online entries and payments via Top Dog Events (<u>https://www.topdogevents.com.au</u>).

Hot Weather Rules: If required the Dogs SA hot weather rules for Scent Work will be applied. If cancelled due to the Hot Weather Rules, Extenuating Circumstances or the Extreme Weather and Safety Rules, the event will be postponed and a new dated determined.

IMPORTANT NOTE: As there is an All Breeds Championship shows on at David Roche Park on March 2nd any competitor with reactive, anxious or nervous dogs <u>are strongly advised not to enter</u> their dog and attend as an observer only. All car parks will be busy and competitors are likely need to walk their dogs some distance past a lot of dogs to the search area. The marshalling point for the search will also be next to the off-lead dog area.

<u>Welcome</u>

Thank you for your entries and also to the members of the Scent Work Advisory Committee for assisting with the running of this Mock trial.

Please remember that everyone involved in this mock trial is a volunteer so please be respectful of all those giving up their time to provide you and your dogs with this opportunity.

Competitor check in and vetting

Competitor check in will occur under the verandah of the Kings Room at the time specified on the schedule for each of the elements.

Please do not bring your dog with your to check-in.

Competitor briefing

The briefing will occur at the times specified on the schedule in the same area as the competitor check-in.

No dogs are to be present at the competitor briefing.

Search areas and trial precinct

All competitors should ensure that they are familiar with the areas indicated on the following pages that can be accessed on the day of the mock trial and those area that should not be accessed unless under direction of a mock trial official. Please also remember that that there is a Championship show occurring at David Roche park on the same day so please be courteous to all those on the grounds.

Running of searches

Competitors will be judged according to the catalogue order as listed unless other wise instructed at the competitor briefing. Trial officials may complete their searches before judging of the remaining competitors commences. Any competitor who does not present for their search in catalogue order without prior approval of the trial manager/secretary in consultation with the judge, will be excused and not allowed to participate in the search.

Spectator Gallery

A spectator area will be available for this trial for those who have purchased Observer Only positions. Section 11 of the rules relates to spectators. All competitors and potential spectators should ensure they are familiar with the rules. Note: usually a spectator gallery is not available for Novice searches so the best way to see searches under trial conditions at the Novice class is to volunteer as a steward for a trial.

For those attending as Observers – on the day you will be able to have a water bottle with you. Please do not bring any food into the Kings Room.

Anyone suspecting that there has been communication between a spectator and competitor should raise their concerns <u>immediately</u> with the SACA rep or any other trial official.

<u>Results</u>

It is the intention that results will be available for competitors to review on Top Dog Events one to two days after the mock trial.

Catering

As there is a Championship Show on there well be catering available at the Dogs SA grounds on the day of the mock trial.

Competitor Reminders

While competitors should always read the rules for the sport and be aware of their responsibilities as an exhibitor, they are strongly encouraged to refresh themselves on the following rules and codes. While this is a mock trial and therefore some of these rules won't necessarily be enforced, it is still good practice for all in volved to be familiar with trial rules and conditions:



Trial Logistics and Parking

Competitors are able to park anywhere within the Dogs SA grounds. The search area is located in the Kings Room which is accessed via the back parking area. For people new to scent work - please just note for most trials parking will be more specific and competitors should always check any parking instructions carefully provided in the catalogue. Handlers are able to use the off lead area as per normal rules for the space but are asked to enter and exit via the gate furthest from the Kings Room. Competitors entered in the trial should not bring dogs within the fenced area immediately around the King's Room at any time unless under the direction of an offical from the mock trial. If they are unlocked competitors can access the toilets at the end of the Kings Room building. If these are not open then please access the toilets in the main building on the grounds. Just ask at check in where they are.
