^{^^}The Novice Vehicle Search will include an extended briefing to guide competitors through what they can expect at a trial and some of the more important rules. An extended debrief will also be provided after all competitors have searched. All competitors should however still ensure that they have read the ANKC Rules for the Conduct of Scent Work Trials (<https://dogsaustralia.org.au/members/rule-regulations/rules/>)

^{**}Observer only positions are available for both the morning and the afternoon elements. Usually Novice elements do not allow spectators but since this is a mock trial a small number of places are available for those not comfortable to enter. It is expected that observers will still attend for check-in, competitor briefings and debriefings. Observers book in for either the morning or the afternoon session but will have some flexibility to move between the two search areas once judging starts.

Target Odours: *Novice* – Anise; *Advanced* – Anise, Clove; *Excellent* – Anise, Clove, Cypress; *Masters* - All

Check-in and Judges Briefing: As specified above. No dogs to be in the check-in area. Competitors with entire bitches are responsible for ensuring their dog is not in season prior to attending.

Entry fees: All elements: \$10.00; Observers only: \$5

Catalogue: Available from Top Dog events or Scent Work SA Facebook page 2 days prior

Entry Limits: Entry limits as specified above. Once limits are reached no further entries will be received. Only one entry per class per handler. Handlers can enter a maximum of 2 eligible elements. If caps are not reached then additional entries will be allowed.

Entries: Online entries and payments via Top Dog Events (<https://www.topdogevents.com.au>).

Hot Weather Rules: If required the Dogs SA hot weather rules for Scent Work will be applied. If cancelled due to the Hot Weather Rules, Extenuating Circumstances or the Extreme Weather and Safety Rules, the event will be postponed and a new date determined.

Welcome

Thank you for your entries and also to the members of the Scent Work Advisory Committee for assisting with the running of this Mock trial and the judges who have offered to judge an element for you today.

Please remember that everyone involved in this mock trial is a volunteer so please be respectful of all those giving up their time to provide you and your dogs with this opportunity.

Competitor check in

Competitor check in will occur in the carpark at the time specified on the schedule for each of the elements. There will be no formal vetting. Competitors with entire bitches should ensure they are not in season before attending.

Please do not bring your dog with you to check-in.

Competitor briefing

The briefing will occur at the times specified on the schedule in the same area as the competitor check-in.

No dogs are to be present at the competitor briefing.

Search areas and trial precinct

All competitors should ensure that they are familiar with the areas indicated on the following pages that can be accessed on the day of the mock trial and those area that should not be accessed unless under direction of a mock trial official. Please also remember that there is a Championship show occurring at David Roche park on the same day so please be courteous to all those on the grounds.

Running of searches

Competitors will be judged according to the catalogue order as listed unless other wise instructed at the competitor briefing. Trial officials may complete their searches before judging of the remaining competitors commences. Any competitor who does not present for their search in catalogue order without prior approval of the trial manager/secretary in consultation with the judge, will be excused and not allowed to participate in the search.

Spectator Gallery

A spectator area will be available for this trial for those who have purchased Observer Only positions. Section 11 of the rules relates to spectators. All competitors and potential spectators should ensure they are familiar with the rules. Note: usually a spectator gallery is not available for Novice searches so the best way to see searches under trial conditions at the Novice class is to volunteer as a steward for a trial.

For those attending as Observers – on the day you will be able to have a water bottle with you. Please do not bring any food into the spectator gallery.

Anyone suspecting that there has been communication between a spectator and competitor should raise their concerns immediately with a trial official.

It is the intention that results will be available for competitors to review on Top Dog Events one to two days after the mock trial.



Trial Logistics and Parking

Parking

Competitors should park in the areas as indicated below. Please note that minimal screening will be in place to protect line of sight to search areas so competitors should consider this when moving around the carpark.



Those attending in an observer only role and not competing in any elements can park in any area designated as No Parking

Dog Toileting

Dogs can be toilet in the area behind the competitor parking area and back up along Saints Road.



Access to toilets

Competitors should access the toilets via the path heading from the carpark near the disabled parking spaces and stay on the path between the disabled toilet and the main building. All competitors should then return the same way. The female toilet will be out of bounds to competitors and all competitors will need to use either the male (exactly the same as the female) or disabled toilet. As the area around the toilets will be used for marshalling of competitors and is near the search areas competitors should not linger in this area. Please also be mindful that cars in this area may have dogs in them so please consider this when moving around in the area
