*** PLEASE NOTE

Seismic Road, from Neeves Rd to Silver Road, between the Boom Gates is OUT OF BOUNDS. It is a private Bitumen Road owned by a Sand Mining Company, used by heavy Trucks. ATC Members or Invited Guests IE Tracklayers have NO PERMISSION to drive on SEISMIC Rd at any time. **BEWARE OF SAND TRUCKS**

***Dogs Reward and Tradition ...DOGS REWARD in sealed BAG please hand to your Judges steward.** On arrival to Base Camp the handler is to hand their Steward a sealed bag containing their dogs treat or toy. At the Judges discretion this may be carried by the Steward to the end of the track **OR** taken by the Tracklayer before commencing walking the track to REWARD the dog at the end.
This bag should be **clearly marked with Handlers and Dogs NAMES.**
It is an ATC traditional to add a small **“Thank you”** in the form of a Snack /Chocolate bar or similar, for the Tracklayer in appreciation for volunteering to be YOUR Tracklayer.

***To comply with ATC Domestic Rules** No dogs are not permitted in Base Camp around food preparation, or at Presentations over Lunch. All Dogs are to be secured in well ventilated vehicles, or crated alongside your vehicle with ample water and shade.

***Competitors and Tracklayers** to remain in different locations /separated as some Tracklayers are unknown to the handler of the dog.

***Your designated Judge and Steward** will give you instructions on arrival at base camp to where and at what time you will be needed. Plus a Running Sheet /Timetable from each Judge will remain at Base Camp with the Chief Steward

***Please bring your own Chair and Travel Mug** to be environmentally aware.

***ATC provides morning tea AND lunch.** Please help yourself. Tea, coffee milk etc. is at Base Camp for **ALL in attendance.** If you are an aspiring cook or not ...we welcome your contribution for morning tea, thank you.

If you have special dietary requirements, please BYO.
